I drive the strategic delivery of population health initiatives from the perspective of medicines optimisation. My role involves spearheading data-driven approaches to improve prescribing quality, address health inequalities, and enhance system efficiency. I provide clinical expertise and oversee complex projects, ensuring alignment with national policies and local healthcare needs.

In this role, I have successfully implemented solutions using Python, SQL, and Power BI to deliver actionable insights, develop interactive dashboards, and streamline decision–making processes for medicines optimisation and population health management.

Examples of completed/ongoing work include:

- Collaborating with the ICB data team to access, and create insights with patient-level data. Previously the Medicine Optimisation team has been limited to practice-level.
- Creating an Opioid dashboard to convert all opiates to oral morphine equivalent, to identify and prioritise reviews of patients being over prescribed opiates.
- Leveraging AI to audit repeat prescription adherence at a system-wide level.

Collaborated with specialists to ensure patient access to medicines mandated by new NICE technology appraisals (TAs) while optimizing care pathways to align with national and local guidance and minimize waste.

Key Achievements:

- Integrated Blueteq platform data with secondary care activity data, resolving data-matching limitations.
- Redesigned Blueteq forms based on NICE TAs, reducing forms by 70% and saving ~30 hours of admin and pharmacist time monthly.
- Developed primary care guidance with NSFT during the ADHD medicine shortage.
- Created an oxygen data dashboard to identify primary care patients needing review.
- Completed high-cost drug pathways for rheumatology, ophthalmology, and gastroenterology.
